

## **PAYMENT STANDARDS 2022 - 2023**

Payment standards are used to calculate the maximum subsidy that the Housing Authority of Fulton County will pay toward rent and utilities for families with Housing Choice Vouchers. Owners and tenants can identify the applicable payment standard area using the ZIP code where the unit is located. To determine the applicable payment standard amount for a rental unit, please refer to the table below. THESE ARE NOT RENTAL NOR VOUCHER AMOUNTS.

<sup>\*\*</sup>The payment standard is the maximum subsidy a PHA can pay on behalf of a family. Families may select units with rents that are more or less than the PHA payment standard, although the initial rent burden at lease-up may be no greater than 40 percent of monthly adjusted income. The payment standard amount is an allowance for any tenant-paid utilities as well as rental assistance. All rents are subject to rent reasonableness determinations by the Housing Authority of Fulton County. \*\*
